## **COMPANY PROFILE**

AGCI (General Association of Italian Cooperatives) was founded in Rome in October 1952 and, pursuant to and by effect of D.L.C.P.S. n. 1577 dated 14/12/1947, it achieved official legal recognition with Decree n.48 of the Ministry of Labor and Public Welfare, dated 14/12/1961 and published on the Official Journal on February 22nd 1962.

Due to its story and consistency, AGCI is therefore one of the major National Association active in the representation, assistance, protection and revision of the Cooperative Movement. It is a not for profit, free and independent organization which, in coherence with the Mazzini's values and those identified as essential by the International Cooperative Alliance (ICA), promotes the dissemination, strengthening, integration and development of the Cooperative Movement. At the same time, it complies with the principles of democracy and mutuality and operates in the general interest of the country's economy. AGCI has its headquarters in Rome but operates throughout the country thanks to 19 regional representations, 8 provincials, 5 interprovincial and 35 territorial delegations.

Moreover, there are 8 sectorial category Associations, which group all organizations carrying on the same activities or similar/connected ones. Furthermore, AGCI is part of important European and international representative organizations in the cooperative sector (Cecop, Cogeca, Cecodhas, Cicopa, Cooperatives Europe, ICA), in which it plays an important role in the safeguard and the promotion of the cooperatives in the various territorial and sectorial scopes.

AGCI is also signatory of 14 national labor collective agreements, 1 agreement for the management of cultural heritage services and 1 Memorandum of understanding relevant to portage.
